# Did You Know?

All students are required to maintain Satisfactory Academic Progress (SAP). In addition to maintaining the basic eligibility that allows you to get financial aid, regulations require that students meet specific <u>Satisfactory Academic Progress</u> requirements.

SAP is calculated by measuring: GPA, Completion Rate, and Maximum Time Frame.

### **Be SAP Savvy!**

- Maintain a 2.0 overall GPA
- Complete at least 67% of all units attempted
- Complete your SRJC program of study within 150% of the program length.

#### Note:

Federal regulations do **not** allow academic renewal to be considered when calculating SAP. All units, regardless of when they were attempted count towards SAP.

SRJC Student Financial Services includes the departments of Financial Aid, Scholarship, and Veterans Affairs.
